## SYNOPSIS

Requires MVC to waive knowledge test requirement for certain military service members who apply for commercial driver license.

1 AN ACT concerning commercial driver licenses and amending 2 P.L.2013, c.48. 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 7 1. Section 1 of P.L.2013, c.48 (C.39:3-10.17b) is amended to 8 read as follows: 9 1. a. As used in this **[**act**]** section: "Commercial motor vehicle" means a motor vehicle or 10 combination of motor vehicles used or designed to transport 11 passengers or property that has a gross vehicle weight rating of 12 13 26,001 or more pounds or displays a gross vehicle weight rating of 14 26,001 or more pounds or a gross combination weight rating of 15 26,001 or more pounds inclusive of a towed unit with a gross 16 vehicle weight rating of more than 10,000 pounds. The term shall 17 not include any of the other types of vehicles listed under the 18 definition of commercial motor vehicle pursuant to section 3 of 19 P.L.1990, c.103 (C.39:3-10.11). 20 "Military commercial driver license" means an authorization for 21 a person to operate a commercial motor vehicle which is issued by any branch of the active duty or the reserve component of the 22 23 Armed Forces of the United States or the National Guard of any 24 state. 25 b. Notwithstanding the provisions of section 4 of P.L.1990, 26 c.103 (C.39:3-10.12) or any other law to the contrary, the Chief Administrator of the New Jersey Motor Vehicle Commission shall 27 28 waive the knowledge test and skills test required pursuant to section 29 4 of P.L.1990, c.103 (C.39:3-10.12), as applicable, for a 30 commercial driver license applicant who has experience operating a 31 commercial motor vehicle while serving in the military and who 32 submits satisfactory proof that the applicant meets the requirements 33 for such a waiver under the federal "Commercial Motor Vehicle 34 Safety Act of 1986," as those requirements are set forth in 49 C.F.R. 35 s.383.77. 36 c. In order to qualify for the [waiver] waivers permitted under 37 subsection b. of this section, an applicant for a commercial driver 38 license shall submit to the chief administrator, in addition to the 39 application: 40 (1) satisfactory proof that the applicant is a member of a branch 41 of the active or the reserve component of the Armed Forces of the 42 United States or the National Guard of any state, or that the applicant is a veteran who received an honorable discharge from a 43 44 branch of the active or reserve component of the Armed Forces of 45 the United States or the National Guard of any state; 46 (2) the applicant's military commercial driver license or other 47 documentation certifying the applicant's experience in the operation

1 of a commercial motor vehicle while serving in the military; and 2 (3) any additional documentation that the chief administrator 3 deems necessary to determine the equivalent class of commercial motor vehicle that the applicant is authorized to operate. 4 5 d. A waiver shall not be granted under the provisions of this 6 [act] <u>section</u> if the granting of the waiver would place the State out 7 of substantial compliance with the requirements of the federal 8 "Commercial Motor Vehicle Safety Act of 1986." 9 e. Nothing in this section shall be construed to exempt an 10 applicant for a commercial driver license from any other State or federal requirements for obtaining a commercial driver license or 11 any endorsement thereon, including, but not limited to, the 12 submission of fingerprints and a criminal history records check. 13 14 (cf: P.L.2013, c.48, s.1) 15 16 2. This act shall take effect on the first day of the sixth month 17 next following the date of enactment, except that the chief 18 administrator may take such anticipatory actions in advance thereof 19 as may be necessary to effectuate this act. 20 21 22 **STATEMENT** 23 This bill requires the Chief Administrator of the New Jersey 24 Motor Vehicle Commission to waive the knowledge test 25 requirement for certain military service members who apply for a 26 27 commercial driver license. 28 Under the federal "Commercial Motor Vehicle Safety Act of 29 1986," the federal government requires the states to meet certain standards governing the issuance of commercial driver licenses. 30 31 These standards include the requirement that every applicant pass a 32 knowledge test and a skills test before obtaining the license. 33 However, federal regulations allow the states to waive these testing 34 requirements for military service members who meet certain conditions set forth by the federal government (49 C.F.R. s.383.77). 35 36 As authorized, the State currently requires the MVC to waive the 37 skills test requirement for qualified military service members who 38 apply for certain commercial driver licenses. Under the bill, the 39 MVC would also waive the knowledge test requirement for 40 qualified military service members. As required by federal regulations, a current or former military service person may qualify 41 for the knowledge test waiver if, during the one-year period 42 43 immediately preceding the date of application, the person: (1) was 44 regularly employed as an operator of certain military vehicles; (2) 45 operated a vehicle that is representative of the type of commercial motor vehicle that the person expects to operate; (3) has not 46 47 simultaneously held more than one civilian license; (4) has not had 48 any license suspended, revoked, or canceled; (5) has not been

convicted of certain types of serious traffic offenses; and (6) has not
 been convicted of certain types of motor vehicle violations arising
 in connection with a traffic accident and has no record of an
 accident in which the person was at fault.

However, under current State law, military applicants who seek 5 to operate the following categories of commercial vehicles are not 6 7 permitted to receive the skills test waiver: (1) vehicles designed to 8 transport 16 or more passengers; (2) vehicles designed to transport 9 between eight and 16 persons if used to transport such persons for 10 hire on a daily basis to and from places of employment; (3) vehicles 11 used in the transportation of hazardous materials; or (4) vehicles used for the transportation of children to or from a school or other 12 13 similar places of education. Similarly, these applicants would not 14 qualify for the knowledge test waiver provided under the bill.
