3 3. "Hostler service" means the movement of locomotives that are 4 not attached to rail cars within a rail yard.

⁵ B. Any person, firm, or corporation operating a railroad train ⁶ in connection with carrying freight in this state shall have at ⁷ least two certified crew members aboard the railroad train while the ⁸ railroad train is in motion.

9 С. The provisions of this section shall not apply to: 10 1. Trains that are used primarily for the purpose of 11 transporting people from one location to another or are used for 12 tourism purposes such as scenic, historic, or excursion rides; 13 2. A locomotive or group or locomotives that are traveling no 14 faster than thirty (30) miles per hour outside of a rail yard and 15 are attached only to a caboose;

18 5. The movement of a train for the purpose of loading or 19 unloading freight, provided that the train is moving no faster than 20 ten (10) miles per hour.

D. The Department of Public Safety shall have the authority to issue a citation to any person, firm, or corporation that violates the provisions of this section. Such person, firm, or corporation shall be subject to a fine:
